

## TOWN OF NEW PALTZ, HUDSON VALLEY, NY



- Elected officials want to exceed code
- Adopted Green standard based on ENERGY STAR for new residential in 2007
  - Use HERS raters
  - Plan reviews and REScheck reports
  - Full performance code compliance
  - Mandatory Performance testing
- Paid for by Builder / Owner

### Benefits:

- Reduced burden on CEOs
- Raters help streamline and increase compliance
- Provides options for builders
- Perception of increased home value
- Builders / Real Estate became excited

# **IBTS ENERGY CODE SERVICE LESSONS**
